6. SBM report and budget monitoring period 11 RW presented SBM report to the F&HR Committee in SP's absence. There were no significant variances since Period 9 report. GM noted the carry forward of £ 8,775 for Pupil Premium Grant Fund (PPG) and asked if this was because a Family Support Worker (FSW) had left and not been replaced. AH assured the committee that the pastoral team was well resourced. Devolved Formula Capital (DFC) RW mentioned the roof survey which had thrown up a repair bill in the region of £300k. This will, in theory, be funded by West Berkshire Council (WBC), as the project was overseen by them, although The Winchcombe are liable for 5% of the	1

	RW circulated his own spreadsheet to demonstrate the revenue balances year on year (including 2 year	
	forecast).	
	RW explained that he and SP have been through	
	the School Improvement Plan Financial Spend	
	2018-19 and were satisfied that all school priorities	
	listed were funded in 2018/19 or will continue in	
	2019/20 and as such are included in the 2019/20	
	budget plan.

	AH advised that the 0.6 year 5/6 teacher employed	
	in 2018/19 has worked out well and wished to continue this appointment. AH went onto say that	
	that there are 4 teacher going on maternity leave,	
	so the school took the opportunity to advertise	
	early. The committee learnt that two highly	
	experienced teachers had been appointed together	
	with a Newly Qualified Teacher (NQT) in anticipation	
	of future vacancies. AH understood that this	
	presents a risk, and was cautioned against this by	
	SP, however believed there would be scope as it	
	would not be clear until 31st May 2019 if there	
	would be any teacher resignations. The committee understood this approach in terms	
	of attracting high quality professionals to the	
	school.	
	The committee were concerned about the predicted	
	deficit budgets in 2020/21 and 2021/22. AH	
	explained that WBC have introduced a new	
	budgeting tool and SP had mainly concentrated on	
	presenting a balanced budget in 2019/20.	
	Governors had the same concerns about PPG and	
	DFC funds, although the other Funds (SAL, LAL,	
	Sports Fund and Phoenix Club were as expected).	
	It was pointed out that this was a draft budget and there would be time for further scrutiny on years	
	2020/21 and 2021/22 before the 2019/20 Budget	
	and Two Year Forecast is presented for approval at	
	the meeting of the full Governing Body on 2 nd April	
	2019.
