6.	Governor Training and recruitment NP has completed a skills audit of the GB and there is a deficit in finance and local community experience. A governor recruitment appeal has been circulated in the school newsletter and the listing with Newbury Volunteer Bureau updated. RW asked the clerk to contact the parents who stood for last year's parent governor election. NP agreed to post an advertisement with Newbury and West Berkshire's Facebook page. 7.	School Improvement Plan (SIP) AH gave an overview of the SIP and the school's priorities. Governors were pleased to learn the golden mile and healthy living is progressing. RW was keen that the outdoor space project be included in the SIP, and its progress publicised. AH advised that the children involved in the workshops have been consulted and are enjoying the improvements so far which have had a positive impact on behaviour during outdoor play. RW asked about pupil premium grant (PPG) spend and ES pointed out that a report of PPG spending and impact is displayed on the school website.	
8.	Safeguarding report RR advised that she met with the pastoral team this term. She found the team very positive and responsible, with a number of complex families to support as well managing behaviour. RR advised that she was able to signpost organisations that may be able to provide additional support to the team and parents. CH asked about promoting the pastoral team so that parents know who to approach for help. AH mentioned that the family support workers (FSW) are outside the gates in the mornings when children are arriving to school and there are plans for a regular slot in the newsletter. AH acknowledged that the lack of space for regular coffee mornings was an issue and hoped to resurrect these in the future when the Happy Kids space becomes free.

	AH went onto to say that the school was successful in recruiting a Social, Emotional and Mental Health (SEMH) practitioner from WBC's Behaviour Intervention Team (BIT). In the light of diminishing support from the LA for these types of services, governors were glad that the school is committed to providing this support in house.
